Minutes for Feb. 5, 2015 meeting Town office, So. Londonderry

1. Meeting was called to order at 7:06 PM by Danny Cobb, chair.
2. There were no additions or deletions to the agenda.
3. **Minutes** of last meeting. Comment: Duane has plenty of letters for corner markers.

4. Bills/invoices

\$1,080 – more work at Glebe View (has been paid, Duane and Melissa).
\$410 – Middletown culvert (has been paid, Duane and Melissa).
\$2,624 – Austin memorials, more stones. Has been paid.

7. Maintenance of cemeteries

Work for 2014 was completed. Everything is currently under snow!

- *Laurie moved and it was seconded that we purchase the right number of flag markers, metal. Melvin will do his best to order markers specific to the person. Melvin will also order extra 'poles' for the markers, a couple of dozen. In the spring we will work on getting the poles of the markers straighter.*

Graves without stones:

Duane had spoken spoke with Carroll Wade, son Carroll Wade, okay for one stone for both parents.
Elsie Ray A. Sexton, (Nikki Alexander's baby) (Melissa spoke with her, she is okay with stone)

- *Gary moves, Laurie seconds, that Melissa order two stones (above), to be put in in the spring. Passed unanimously.*

8. Sale of cemetery plots

One plot sold last year. Natalie L. Raymond, No corner stones yet (Spring).

- *Laurie moves that we raise the price of the corner stones to \$200, Gary seconds. Prices of the plots will remain the same as 2014.*

9. Old Business

Review of proposed contract with Hart's All Season Maintenance.

Melvin looked in the Cemetery Commission minutes: Duane and Melissa took over the care taking of the cemeteries on March 20, 1997.

FYI Duane's services: (\$90 for cremation, \$450 for a full burial)

- *Laurie moved that we accept the contract with Hart's All Season Maintenance, Melvin seconded. Motion passed unanimously.*

Laurie to send copies of the signed contract to the whole Cemetery Commission and to Tina Labeau at the Town Office.

Melissa and Duane will take care of the signs that need to be replaced. Duane will check in with Paul Gordon re: some new signs.

Glebe View property line with Mr. Sullivan - discussion re: work that still needs to be done. Melissa raises the question of planting trees along the property line?

Danny mentions that the Cemetery Commission received over \$64,000 in interest (FY 2014) which has been re-invested.

10. New business

Trustee of Public Funds meeting tomorrow morning (Friday, Feb. 6th) at the bank, 8:30 AM. Danny will attend.

Melissa asked that we put a notice in the paper (in the spring) regarding no new in-ground planters and no fences around the stones.

Gary is up for re-election, he would like to serve again.
